## **City Manager Update**

## Dear Constituents,

Yesterday afternoon I received a telephone call from the city clerk notifying me that a special meeting of the City Council will be held on Monday for the purpose of conducting interviews for our city manager. In case you were not aware of it, last Monday we spent the entire day interviewing seven (7) candidates for this position. At the conclusion of the interviews, we selected three finalists and set the date of August 13 for the final interviews. I questioned the city clerk as to why the date is being moved up; I received a very evasive answer.

I just want you to know that I have no idea what is taking place here, but I am very suspect as to why the planned timeline for these interviews was changed from August 13 to Monday. Even though the council majority clearly ignores community input and moves forward with their own agenda, just a large group of people attending this meeting, and some of you coming to the microphone to encourage the council to select the best qualified candidate, may have an effect on the final decision. I NEED HELP on this one and sincerely hope that you can attend. I'm all by myself up there, and it is difficult to protect the community from what this council majority is doing to our beloved city!
